

Coronavirus (COVID-19)

We are living in extraordinary times and are often given mixed information regarding the coronavirus, and complete disruption of our normal lives. With all the uncertainties, one thing must remain constant and that is the education of our children. Our children's futures must not be hindered by the circumstances of today.

Top medical scientists and statistical data have confirmed that children (without underlying medical issues) are at the least risk of contracting, dying, or spreading coronavirus. I know many of us are fearful of having our children being sick, but we have to educate ourselves of the facts. The facts support children are of least risk. Given these facts, Cincinnati Technology Academy opened school as close to normal as possible. With some noticeable changes to provide extra precautions:

- 1. All staff, students and visitors must wear a facial mask (covering mouth and nose)
- 2. All staff, students and visitors have their temperature taken prior to entering the building
- 3. All staff must have their temperature recorded daily
- 4. All students will have their temperature taken in homeroom with a non-contact thermometer
- 5. Students are separated in cohort groups
- 6. Hand sanitizer will be available in all rooms in the building and hand washing will be a scheduled routine for all our students
- 7. The school has purchased special sanitizing equipment to disinfect the entire school daily
- 8. Students utilize water bottles
- 9. Cincinnati Technology Academy complies with State and Local requirements to report incidents of infections

Our staff, parents and students have risen to the challenge to keep our children safe and healthy. This effort has tremendously benefited our students academically and emotionally.
